This matter comes before the Hearing Officer on a Motion to Continue the Rulemaking Hearing filed by the Colorado Automobile Dealers Association (CADA) on September 28, 2018. CADA requested that the rulemaking hearing be continued from November 14-16, 2018 to December 20-21, 2018.
